INSERT INTO RULE 8 (CLUBS AND SOCIETIES), SECTION 2 (PROCEDURE FOR RECOGNITION OF A CLUB OR SOCIETY) THE FOLLOWING CLAUSES AND RENUMBER EXISTING CLAUSES ACCORDINGLY:

Any Student Member making an application for recognition of a Club or Society must declare any actual, perceived, or potential conflict of interest, direct or indirect, relating to the application. The Council, or sub-committee of Council, when considering an application for recognition:

- shall consider any declared conflict of interest and any other relevant available information suggesting any actual, perceived, or potential conflict of interest;
- make a determination on the Student Member's involvement in the recognition process; and
- may invalidate an application from a Student Member if recognition could feasibly result in direct or indirect pecuniary benefit to the Student Member.

10.1 **A review on the Irish Language Policies (Athbhreithniú ar na polasaithe Gaeilge)**

This Council acknowledges:

- That there are Policies regarding the Irish Language and Bilingual Signage in the Students Union Policy File.

This Council recognises:

- That the Identity and Language Act 2022 (Acht Féiniúlachta agus Teanga 2022), gave the Irish language equal status to the English Language, and that Irish is an official language of the state.

This Council Believes:

- That the Students Union should work towards implementing the policies set out in the file regarding the Irish Language and Bilingual Signage.

This Council Notes:

- That in 2018, policy ‘8.15. Bilingual Signage on Campus’ was added to file and the council mandated: *“That the VP Equality and Diversity and Students’ Union President work closely with An Cumann Gaelach to ensure that the bilingual signage is returned across campus at Queen’s University Belfast and Queen’s University Students’ Union.”*
- That in 2020, policy ‘8.22. Irish Language Rights’ was added to file and the council mandated: *“QUBSU to develop a campaign along with NUS-USI, USI and other Students’ Unions to prevent cuts to Irish language courses, for the expansion of courses able to be studied jointly with Irish, increase funding to Irish faculties and to support the lobbying and activism of An Cumann Gaelach and the work of an Oifigeach Gaeilge.”*

This Council Mandates:

- That the Students Union will revisit all previous Irish Language Policies on file and work to ensure the implementation of what is set out in the policies.
- That Student Officers continue to support campaigns of An Cumann Gaelach and work together with An Cumann Gaelach to ensure previous Irish Language policies are implemented.

This Council Encourages:

- That the Students’ Union arrange work with the Irish Language Commissioner An Coimisinéir Teanga to continue the promotion of the Irish Language An Ghaeilge in the Students’ Union and within the University.
- That the Students’ Union continues to engage with AMLÉ looking to their forward-looking Irish Language policy for guidance on the support for Irish Language development within Queen’s University Belfast.
