PESCHA – Pan European Student Co-operative Housing Association	SO Welfare, NUS-USI President and I, went on a trip to Geneva, alongside 2 other student housing co-operatives on the Island. This was a conference held to get co-operatives across Europe together to discuss best practice, common challenges and how best to continue promoting the co-operative movement. We spent the first day exploring the experienced and mature housing co-operatives of Geneva, and learning about the history of how they emerged so prominently in the region. The second day we attended presentations from German, Hungarian, French, Italian and UK co-operatives, to see how the models vary and differ in their respective contexts. The day was finished up with workshops, our group attended the ones discussing starting up and finances as these are our biggest challenges now. A key takeaway from the event is around building for scalability. Many of the Co-operatives had flat governance structures and whilst this can work fairly well and avoids complexity and formality – it does ultimately bottle neck growth, as without structures it can be difficult to self-manage beyond 100 people. Building in governance structures and key principles of participation early can avoid these growth traps and provide the framework for managing interpersonal conflict.
