RAG Review

It was agreed by EMC to review the state of RAG for the next year. This decision means that there will be no hiring of a new RAG chair for the next academic year, and charities may still be fundraised for if they wish to be, but no new charities will be chosen in the March elections.

This decision was taken to review RAG because of the diminishing donations since Covid and the Cost-of-Living crisis. Changes to the structure and practice of RAG will be necessary to reach historical expectations. The SU will look into how the rest of the sector manages student fundraising to collate best practice and apply new structures to secure the future of RAG.
